This day shall gentle his condition.



The History of Brock's Monument

Construction of the first monument to Brock began on June 1, 1824. On October 12, 1824, Major General Sir Isaac Brock's body was removed from the bastion at Fort George and interred under Brock's monument in a solemn event. Over 8,000 spectators gathered to watch the procession along the route from Fort George to Queenston. By 1827, the tower was completed and measured 40 metres in height. Throughout the 1820's and 1830's, the first Brock's Monument became a popular destination for early travellers to Upper Canada.

On April 17, 1840, Brock's Monument was severely damaged by a bomb set off at the base of the stairs. It was suspected that the charge was detonated by Benjamin Lett, an American sympathiser who was part of

the Upper Canada Rebellion. The monument's architect, Francis Hall, insisted that it could be restored. However, many felt that a new tower should be erected to highlight their respect for Brock, and the indignation they felt towards the vandalism.

Construction on the second monument to Major General Sir Isaac Brock began in 1853. Designed by William Thomas, the Monument was built entirely out of Queenston limestone, measures 56 metres in height, and was opened to the public in 1859. Each year, thousands of visitors from around the world visit Brock's Monument National Historic Site, learning about the early history of Canada, and the role Major General Sir Isaac Brock and the Battle of Queenston Heights had in shaping its destiny.

DISTRICT ATTENDANCE AWARD



The 2018-2019 District Attendance Award was won by St. George's Lodge No. 15 with 52 members attending the Official Visits of the DDGM. That equates to a 6.6% of their members attending Official Visits (based on a membership of 56). Brock

Daylight Lodge No. 745 came in second place with 50 members attending, which based on a membership of 31 equates a 11.5%-member average turnout. Congratulations to St. George's No. 15 but WELL DONE to the members of Brock Daylight Lodge No. 745.

BENEVOLENCE and **CHARITY**

Perhaps one of the biggest misconceptions amongst Masons is understanding the differences between the Grand Lodge Committee of Benevolence and the Masonic Foundation of Ontario.

The Committee of Benevolence is one of the "Standing Committees" of the Board of General Purpose. It is to administer according to the rules respecting grants for benevolence the investment income from the Memorial Funds and the funds provided by Grand Lodge. Grand Lodge may appoint a Supervisor of Benevolence. It shall be his duty to assemble on behalf of the Committee, the necessary information on applications for benevolence and keep the Committee informed about the financial circumstances of the beneficiaries of the grants. Grants are provided to Masons, or to dependent relatives of a living or deceased Brother. No grants of benevolence would be made to an unaffiliated Mason or his living relatives or dependents. These grants are considered as a supplementary assistance to that given by the Lodge recommending the application.

The Masonic Foundation of Ontario is a separate corporation with its own autonomy and Board of Directors. The foundation is permitted to use its donations within the Province of Ontario for the relief of poverty, the advancement of education and other purposes beneficial to the community. It is committed to funding bursaries, hearing research, drug and substance abuse education in the school systems and other specific and community projects that fall within its guidelines.

The Committee on Benevolence looks inward to the Masonic family, while the Foundation looks outward to the community as a whole. This is an important

distinction, as it permits the Foundation to be registered with the Canada Revenue Agency as a public charitable foundation and to issue tax receipts to anyone who makes a donation.
