From the Grand Master ...

My Brethren:

Getting off the normal track and veering from the game plan can be dangerous sometimes but I feel I must take the chance.... (Spoiler alert – this may not be a Communiqué for sharing with friends and family.)

I will start by repeating a paragraph from last month's Communiqué in case you skimmed over it:

Hanukkah for Jews celebrates the freedom and justice without which there can be no genuine peace; Jesus for Christians is the Prince of Peace; and Muhammad for Muslims is the Messenger of Peace. May we all enter the coming year in a spirit of peace and non-violence, with hearts open to all—including those with whom we disagree. In all we do, in all the uncertainties ahead, may we embody the spirit of Rabbi Hillel, who taught "Do not judge your fellow until you are in his place" (Pirkei Avot 2:5); of Jesus who said, "Blessed are the peacemakers" (Matthew 5:9); and of Muhammad to whom God said, "We have sent you, O Prophet, as none other than a mercy to all the people of the world (Qur'an 21:107)."

I used to hear Grand Masters of yore and past Chairmen of Discipline regret in their year end reports that the worse part of their job that year had been dealing with all the Masonic charges, complaints and 'private piques and quarrels' over the past year. And I would think, 'we're all Masons, surely these Masonic leaders must be exaggerating?'

But as Masons, isn't any time spent in this area too much? How can we profess to be Masons, follow what we are taught and vow to uphold the principles we do, yet ignore them when it is convenient, or we feel slighted?

When we look outside our Masonic Temples, it is true, we are living in a world that is spiraling out of control. From natural disasters to violence against the innocent it is hard to imagine a time or a place when this wasn't the case. The rise of hatred in the world continues to overshadow all positives. If we can't live in peace in our own Temples, our teachings will end there.

In this season of peace, regardless of your religion or affiliation, I implore you to find a way to set aside the hate which comes with stereotypes or preconceived notions. Make room in your heart for kindness and forgiveness. More than ever the world needs our efforts in this endeavour. More than ever our Fraternity needs our efforts in this endeavour.

I hope everyone who reads this can start the New Year off anew and celebrate the idea of peace on Earth and goodwill toward ALL mankind starting with ALL your Brothers in Masonry.

My Brethren,

The District Deputy Grand Master's regional meeting is this month and as I have been putting all of the District Reports into one big report, I have noticed many commonalities across the entire Jurisdiction. I was talking to one Brother and he stated that his Lodge was close to not being viable so a letter was sent out to its members stating the honest facts that if something didn't change, they were in jeopardy of going dark. He said that the letter worked and the members started to return to Lodge, activity was going well and it looks like the Lodge will be going for many years to come. That sounds like a great outcome for them but it takes work, commitment and dedication. I realize that small rural Lodges have a harder time drawing in new members due to their geographical area but they must still try to retain the members that they have. Let's face it, if the Lodge has open and honest discussions and seeks out help, its chances of survival increase tenfold. There are many Committees at our Grand Lodge that can help and engage the membership and even help to bring in new

members. From having Masonic Education at every meeting, exemplifying degrees, and implementing the Cornerstone Program to looking into a long-range plan, budgeting and taking a hard look at the finances. All of these aspects of a successful meeting are well worth the effort needed.

Our new branding can also be used in a positive light to let both us as Masons and the public in general know and realize the good that we do. I believe that our new Branding will help out in making us feel good about ourselves and also let our friends and families know of the extreme good that we do for the community around us. The Public Awareness Committee has many ideas to help us promote ourselves in the community.

In conclusion for this month Brethren, I would like to talk about the Lodge Building Advisory Committee. R.W. Bro. In my Lodge, the fire inspection requirement was one of the greatest things that happened to the building. There was only one way out, other than exiting through the windows, and that was a tragedy just waiting to happen. It costs some money but another exit door was put in along with proper exit lighting and a current fire plan in case of emergency. A ramp was added for wheelchair accessibility and now we have a Lodge that is ready for future use as the membership ages.

Brethren, please make your Lodges and Temples as safe as they can be for our members to enjoy.

As always Brethren, let us rub and cherish our shiny penny, plan for a bright future, keep our Lodges vibrant and make someone smile today.
